## UKAS, EA and Accreditation

- **The United Kingdom Accreditation Service (UKAS) is the sole national accreditation body recognised by UK government to assess, against internationally agreed standards, organisations that provide certification, testing, inspection and calibration services.**

## UKAS, EA and Accreditation

- **EA is the European network of nationally recognised accreditation bodies based in the European geographical area.**
- **To ensure transparency of the operations and results of its members**
- **To ensure common interpretation of the standards**
- **To manage a peer evaluation system**
- **To support and promote mutual recognition.**

## UKAS, EA and Accreditation

- **Accreditation provides confidence in and organisations:**
  - **Capability**
  - **Competence**
  - **Conformity**

## Accreditation Process

- **Assessment Team**
- **Accreditation Cycle**
  - **Initial Assessment**
  - **Surveillance/Reassessment**
  - **Unannounced Visits**

## Accreditation Process

- **Can hold accreditation for sampling solely**
- **Assess Sampling Teams on Site**
  - **Live Sampling**
- **Procedures for Sampling**
- **Staff Interviews**
- **Staff Qualifications**

## Why Accredit Sampling?

- **High risk site (remote) based activity**
- **Significant impact on uncertainty of data**
- **Professional Judgment**

## How do we accredit sampling?

- **ISO/IEC 17025:2005**
  - Usually test and calibration laboratories
  - Supported by standards or guidance
  - Concerned with how the sampling is planned, sample is taken, stored and distributed.
- **Examples**
  - Stack Emissions Sampling
  - Drinking Water Sampling

## How do we accredit sampling?

- **ISO/IEC 17020:1998**
  - Inspection activities
  - Professional Judgment
  - Concerned with how the decision to take the sample is arrived at and that the sample is taken, stored and distributed properly and how the results are interpreted.
- **Examples**
  - Inspection of Buildings for Asbestos

## How do we accredit sampling?

- **Personnel Certification**
  - **ISO/IEC 17024:2003**
  - **Delivered by Certification Bodies**
  - **Certification Bodies can be accredited**
  - **Sector Specific Personnel Certification Schemes**
    - **Stack Sampling**

## Accreditation and Sampling Uncertainty

- **Is sampling uncertainty a requirement of accreditation?**
- **Is the lab measuring the properties of the sample or of the body the sample was taken from?**
- **Is the measurement technique considered to include sampling?**

## Accreditation and Sampling Uncertainty

- **What happens if the lab is not the sampler?**
- **Is the sampler/modeler/risk assessor responsible for estimating uncertainty of sampling?**
- **ISO/IEC 17020 – Uncertainty not a requirement.**

## Accreditation and Sampling PT

- **Proficiency Testing – ISO/IEC 17011**
  - **Laboratories required to participate**
- **Would need to consider current policies.**

## Are we getting ahead of ourselves

- **Awareness and understanding of uncertainty amongst labs customers is low.**
- **No drive to report UoM leads to 'basic' uncertainty budgets.**
- **Modelers and risk assessors often state they have included uncertainty in modeling systems.**
  - **Potential for misuse of guidance**
